5.	I agree to contact the District Office at 740-992-4282 when I have finished with the equipment and report the number of acres planted, tons spread, or days used, whichever applies.									
6.	I agree to indemnify and hold harmless the County of Meigs, Ohio, its agents, employees or any other person against loss or expense including attorney fees, by reason of the liability imposed by loss upon the County, for damage because of bodily injury, including death at any time resulting there from, sustained by any person or persons or on account of damage to property arising out of the transportation or use of equipment rented, leased, or borrowed from the Meigs SWCD.
